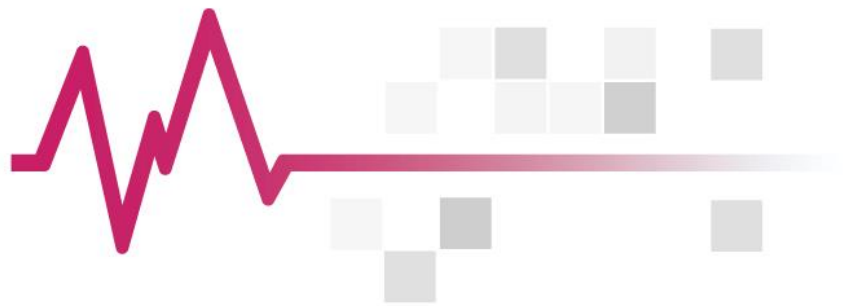

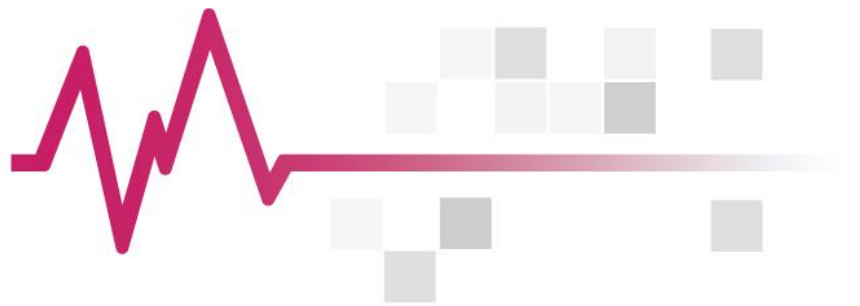
14:15 – 15:00 **panel on Participatory Medicine and Patient Empowerment**
