


Greatest health threat of the century



WMA's Decleration of Delhi on climate and health

 Urgent call for governments to act: national climate actions, finance, healthcare system strenghtening, climate migrants, participation of health sector, capacity building, cross-sectoral collaboration

 Ask to NMAs and physicians to: low-carbon practices, advocacy, medical and post-graduate education, research, collaboration,

WMA's statement on divestment from fossil fuels

- 1.Education: health scientists, businesses, civil society, and governments concerning the benefits to health of reducing GHGs
- 2. Move toward renewable fuel sources.
- 3.Begin a process of transferring their investments, when feasible without damage, from energy companies whose primary business relies upon extraction of, or energy generation from, fossil fuels to those generating energy from renewable energy sources.
- 4. Strive to invest in companies upholding the environmental principles consistent with the United Nations Global Compact, and refrain from investing in companies that do not adhere to applicable legislation and conventions regarding environmental responsibility.




