Please be informed that all interested delegates that require an entry visa to attend this meeting in the United States will be assisted in obtaining a visa in their passports.

#### Registration Terms and Conditions:

The following terms and conditions set out the legal rules applicable to the (VIEID2024) Congress. ## Hotel Accommodation:

Registered Delegates are responsible for their hotel accommodation in Washington D.C. where the congress will be held due to the inability of our sponsor organizations to mobilize enough funds to sponsor the number of expected delegates attending the congress.

## Requesting an Invitation Letter:

For security purposes, letters of invitation will be sent to delegates who have been registered for the congress. Once your registration is confirmed, a personalized letter of invitation will be sent to you.

## U.S. Travel Guide:

Most Canadian citizens and many citizens from Visa Waiver Program countries can come to the U.S. without a visa if they meet certain requirements. Visa waiver travelers from ALL 27 Visa Waiver Program countries must present a machine-readable passport at the U.S. port of entry to enter the U.S. without a visa otherwise a U.S. visa is required.

All participants' visa assistance requests will be forwarded to the U.S. Department of State for visa authorization which shall be sent by fax to the consular section of the U.S. Embassy, in your country of residence. Only on receipt of your filled registration forms, front page of international passport and hotel accommodation confirmation slip, will participant's visa request be forwarded to the U.S. Bureau Department of State for same day visa authorization, which shall be sent to the Consulate Section of the U.S. Embassy in your country of residence for visa collection. You will be given an appointment date to visit the U.S. Embassy for visa collection after the approval of your visa here in the United States. You are to inform us if you already have a U.S. visa when submitting your registration documents.

Air Ticket:

The sponsors/organizing committee is responsible for all registered delegates Air Tickets. The ticket will cover from participant's country of residence to the United States and back to the participant's country of residence at the end of the conference.

Official Language:

The official languages of the congress are English, Spanish and French. However, a simultaneous translation into English will be provided for all sessions that take place in the main congress room. Interpretation in other languages will be available from speech-to-text reporting.
